

# EASY PEASY FORM 4 FILING WITH A TRUST

1. Select the suppressor you want, there are many flavors and many opinions on each. This is the fun part. Let us know what you are wanting and get an AMAZING price from Horace Firearms. Now pay for it, NOT a fun part.

2. Once we are assigned a serial number for your suppressor, we'll contact you and set up an appointment to get things rolling.

3. If you don't already have an NFA Trust, you'll need one. We offer Multi-Firearm NFA Trusts that are valid in all 50 states. A trust allows co-trustees (spouse, kids, etc.) to legally possess your NFA items.

**PRO TIP:** Start with yourself as the ONLY trustee. You can add co-trustees later AFTER your suppressor is approved. This streamlines the process - only ONE person needs fingerprints, photos, and paperwork for the initial application. Add your spouse or kids to the trust after you take possession.

4. Prior to your appointment, the SETTLOR (primary trustee - that's you) needs to set up an ATF eForm account. This needs to be done here: <https://eforms.atf.gov/login> - click on the "Register" button below "Create an Eforms Account". Double check all your spelling and make sure everything is accurate.

5. Note the username that is generated for you, it is generally the first initial of your first name and the first 5 digits of your last name followed by 5 random numbers. Example: jsmith12345. You will choose a 4-digit PIN when registering, make sure you remember that as well, we'll need that when filing.

6. Each "Responsible Person" on your trust must complete ATF Form 5320.23 (Responsible Person Questionnaire). This form collects background information and is required for every trustee who can possess NFA items. If you follow our pro tip above and start as the only trustee, you only need ONE Form 5320.23.

7. For your appointment, you'll need:

- Your driver's license with current address
- Your eForm username and PIN
- A copy of your trust documents
- Completed Form 5320.23 for each responsible person

8. When you arrive for your appointment, we'll take a passport photo and digitally capture your fingerprints. This takes about 15-20 minutes. If you have multiple trustees, each one needs their own fingerprints and photos done.

9. We'll sit down and complete the eForm 4 together online, listing the trust as the transferee. Not any more difficult than filling out a form 4473.

10. Then we hit submit and wait! Hours, days, weeks... nobody knows! They don't have any rhyme or reason; it just takes as long as it takes.

11. When your trust is approved, both you and Horace Firearms will receive an email with your digitally approved form.

12. We will meet up one more time to have you fill out a 4473 form to officially transfer the suppressor out of our books and into your trust's possession.

13. NOW you can add co-trustees to your trust! Once the suppressor is in your possession, add your spouse, kids, or anyone else you want to have legal access. No additional ATF paperwork needed for adding trustees after the fact.

That's it!!

### WHY USE A TRUST?

- Multiple people can legally possess your NFA items (after you add them as trustees)
  - Easier estate planning - items pass to beneficiaries without additional transfers
    - No need to get a CLEO signature
    - Add or remove trustees as needed
